Veterans Day – November 11

Veterans Day is an opportunity to publicly commemorate the contributions of living veterans. Armistice Day officially received its name in America in 1926 through a congressional resolution. It became a national holiday 12 years later by similar congressional action.

If World War I had been "the war to end all wars," November 11 might be still called Armistice Day. Realizing that peace was equally preserved by veterans of World War II and Korea, Congress decided to make the day an occasion to honor all those who have served America. In 1954, President Dwight D. Eisenhower signed a bill proclaiming November 11 as Veterans Day. (Historically, the first Veterans Day parade was held in 1953 in Emporia, Kansas.)

A law passed in 1968 changed the national commemoration of Veterans Day to the fourth Monday in October. It soon became apparent, however, that November 11 was a date of historic significance to many Americans. Therefore, in 1978 Congress returned the observance to its traditional date.

Jack R. Mason, Sr. 89, of Vincennes, IN, died October 8, 2020, at the Bridge-Pointe Health Campus.

He was born on February 15, 1931 in Knox County, IN, and was the son of Sterling Royce and Edna Fern (Pickle) Mason. His parents; his wife, Ruth Jeanette (Arnold) Mason; and his brothers,

Terry Mason, and Franklin Mason, preceded him in death.

Jack served in the U.S. Air Force during the Korean War. After four years, he joined the U.S. Army and served 21 years, including a tour in Vietnam. There he received a Purple Heart and a Bronze Star Medal, with an Oak Leaf Cluster.

He joined the American Legion, 40 & 8, and the VEW, where he was a

He joined the American Legion, 40 & 8, and the VFW, where he was a lifetime member. From 2004 – 2005 he served as the Indiana State Commander in the VFW. A 63-year member of the Masonic Lodge, his membership was eventually transferred to the Pike Masonic Lodge No. 121, F & AM, in Petersburg, IN. He was a member of the Eagles for over 30 years. Jack had enjoyed scuba diving, golf, and playing Texas Hold-'Em. An avid St. Louis Cardinals fan, he also enjoyed watching Jeff Gordon in NASCAR.

Fall Conference set for October 23-25 at Marriott

The Indiana VFW Fall Conference is scheduled for October 23-25 at the Indianapolis Marriott East Hotel. There are apparently still plenty of hotel rooms (please call the hotel to make reservations).

The tentative schedule includes the C of A meeting at 7 p.m. Friday (uniform is the State shirt) with the business session beginning at 9 a.m. Saturday (uniform Blue Jacket, White Shirt, Grey Pants and Tie), and a Mixer at 6:30 p.m.

The Mixer is \$27 per person. It includes: Mini Sweet and Sour Meatballs, Wings with sauces; Potato Wedges, Pizzas and Fruit Cups. Freshly brewed coffee, iced tea, and a cash bar.

There will be no assigned seating and no plated meals. Appetizers will be served from 7 to 8 p.m. Each ticket will come with 2 drink tickets for the bar.

Complete the Airborne Hazards and Open Burn Pit Registry

All veterans who served in eligible locations should include their information in the Airborne Hazards and Open Burn Pits Registry.

Participation in the registry is particularly important as it will allow VA to track burn pit exposure and draw inferences regarding associated adverse health effects. Exposure to burn pits may be associated with respiratory conditions such as asthma, emphysema, chronic bronchitis, and chronic obstructive pulmonary disorder (COPD).

Recently, VA stated that veterans with underlying respiratory conditions may be at greater risk for developing complications related to COVID-19.

Requesting "Conditional" donation

Ceremonial rifles, ammunition, military equipment

Department Adjutants and Quartermasters are asked to remind all Post officers to refer to the revised information located at wfw.org where they will need to log in to the "My VFW" page and select the "VFW Training and Support" link, then "Member & Officer Training, Forms and Templates" where you'll have access to "Training Guides & Standard Operating Procedures" and then click on "Ceremonial Rifles, Ammunition & Military Equipment" when requesting a "conditional" donation of any government military equipment, ceremonial rifles or ammunition.

Before contacting the governmental agency, a formal written request is to be addressed and mailed to the Adjutant General at VFW National Headquarters, and must be completed and signed by the current *Post Commander, Post Adjutant* or *Post Quartermaster*, one of whom needs to be the contact person.

Also, to be included is that contact person's mailing address and phone number, not the Post address. Address the request to the Adjutant General, VFW National Headquarters, 406 West 34th Street, Kansas City, MO 64111.

Include the proper information as outlined in the "Ceremonial Rifles, Ammunition & Military Equipment" pages on the website. It is requested that a Post <u>not</u> go through their Department Headquarters (but send them a courtesy copy). This only slows down the processing and creates unnecessary paperwork for the Department personnel.

Dear Veteran or Beneficiary Travel recipient,

We would like to inform you of changes that have been made to the Beneficiary Travel claim process that will decrease processing time and increase speed of payment. Starting October 5, any new travel reimbursement claims for Beneficiary Travel for VA Northern Indiana Healthcare System Veterans should be submitted through a new web-based portal. The system replaces the kiosk method and eliminates hard copy submissions and in-person claim submissions.

The new Beneficiary Travel Self-Service System (BTSSS) online system will launch October 5 through the Access VA website. The system offers Veterans and beneficiaries the following advantages:

- More convenience and ease in submitting claims 24 hours a day, 7 days a week,
- Timely processing and payment of travel reimbursements,
- Self-help tools to find answers to questions, and
- Capability to track a claim and your complete claims history.

This process will be more technology based, so VA Northern Indiana will be ready to assist Veterans in this transition.

Before logging in to submit a claim, Veterans and family members will need a DS Logon account issued by the Department of Defense (DoD). A DS Logon is an ID that enables Veterans and caregivers to access VA and DoD sites with one username and password. For VA Northern Indiana Veterans that are unsure if they have a DS Logon account or need help creating one, they can call Don McCullough at 800-360-8387 ext. 71327 for assistance.

To submit a claim or get information about a DS Logon, visit < https://access.va.gov/accessva>. Select the description that fits you best (i.e. Veteran, family member, etc) and then choose Veteran Travel Claim Entry or BTSSS. At that point, a DS Logon will be required.

If you need any assistance or more information about BTSSS please contact the VA Northern Indiana Beneficiary Travel Department at 800-360-8387. Once connected to the call center, ask for Beneficiary Travel and they can connect you. During appointments, Veterans can also ask front desk staff for assistance.

Getting a flu vaccine is more important than ever this year to minimize the risk of illness and possible hospitalization. Hand washing, face coverings and social distancing are all important in eliminating infections.

Veteran Health Indiana is providing free flu shots to Veterans through a series of Drive-thru Flu Clinics or at scheduled patient appointments (such as for labs, primary care, nursing, specialty, or behavioral health).

Pearl Harbor Day, December 7 . . .

On the morning of December 7, 1941, Japanese bombers staged a surprise attack on U.S. military and naval forces in Hawaii. In a devastating defeat, the United States suffered 3,435 casualties and loss of or severe damage to 188 planes, 8 battleships, 3 light cruisers, and 4 miscellaneous vessels. Japanese losses were less than 100 personnel, 29 planes, and 5 midget submarines.

The day after the attack, before a joint session of Congress, President Roosevelt asked Congress for a declaration of war against Japan. President Roosevelt's message conveyed the national outrage over the Pearl Harbor attack by pronouncing December 7, 1941 "a date which will live in infamy."

FDR expressed outrage in Japan and confidence in the "inevitable triumph" of the United States. On December 8, 1941, the United States declared war against Japan; on December 11 Germany and Italy declared war against the United States.

VA can assist Veterans resolve community care debts

VA's Office of Community Care (OCC) contact center can help veterans fix issues with credit reports or debt collection actions that are the result of an authorized VA community care claim. Once a veteran contacts VA's OCC contact center, with their information regarding debt collection, staff will work one-on-one with the veteran to research and resolve collection-specific issues. First Indiana Combat Veteran since Spring 2019

Newsletters come in many sizes and styles. With this issue, we are hopeful to produce a quality product which will be available on the VFW Department of Indiana's website. Newsletters are only successful if those individuals who read them also provide news and photos to place in each issue.

Although I had sent out an e-mail to all of the District Commanders and everyone else who helps lead the Indiana VFW, I knew that at the beginning it would be slow and people would have to be reminded several times to provide information to be placed in the newsletter. For several years, we have been producing two copies a year, one in the Spring and one in the fall.

When Commander Capshaw asked me to help out in this area, I agreed because this is what I did for over 25 years and I felt I could be beneficial and help the State VFW to serve its members.

To succeed, we need your help. If we put this out two or three times a year, we need information from as many people as we can get.

For those of you who do not know me, my name is Steve Milbourn. I joined the VFW while serving in Vietnam in the 101st Airborne Division in 1966 and 1967 at Phan Rang. When I returned to Indianapolis in 1967, I was an At-Large member of National Headquarters, I believe. About three years later I accepted a job in Columbus, Ohio and transferred to a Post there. I was active enough to be an All-State Commander twice and in 1985 became an All-American Commander.

After moving back to the Indianapolis area, I became a member of New Whiteland VFW Post 6978. I was not active due to the job I had working from 10 a.m. to 8 p.m. Monday through Friday. I did get down on occasion and have a beer. My wife retired in 2004 and we sold our home and moved to Arkansas for retirement.

I was a member of VFW Post 1674. It had 20 members and it wasn't long before all the members received a post card saying they were going to shut us down. I couldn't get to the meeting but met with the District Commander in advance and signed a sheet of paper that I would help resurrect the Post. The Post had not had a meeting in nearly two years and the only person I knew was the Commander, who did not attend the meeting. None of those in attendance except the District Commander had ever met me. They elected me as Commander. I received the word the next day. When I moved back to Greenwood in 2012, the membership was at 165 and I had become an All-State Commander (Captain) twice; and an All-American Post Commander (Co-Captain); and an All-American District Commander (both All-American's honors were in the same year).

My younger brother and younger sister both became ill about two years apart. My wife and I moved back to Greenwood to be nearer to them. They both passed about three years later. In 2014-2015 I became an All-American Post Quartermaster while at Greenwood VFW Post 5864. I am now in my sixth year and final year as Post Commander.

I have also held numerous other Post, District and State positions through my time. In addition, I have served as the Post's Service Officer and helped over 100 members and other military folks file a claim. Since I never went to school to train as a Veteran's Service Officer, I do the research and provide them with information. It took me 11 years to get to 100%, but I did it myself. This was before there was a rush for everyone to file a claim. I am also retired from that, other than providing information to individuals of what they need to do.

Overall, I enjoy everything I do, but as everyone knows there are always "certain people" who will drive you to drinking.
