Subj: How to Start a Pup Tent IAW Article II, MOC Bylaws, 2 Aug 2024,

Here is a Step-by-Step guide to Start a new pup tent. Begin by going to www.lotcs.org select Forms and then Select Pup Tent Starter Kit and begin to completed the following forms:

1. [NEW PUP TENT FORM](#): Complete the form for the VFW Post Commander to sponsor and support the pup tent. Have the Post approve and get the Commanders signature.
2. [APPLICATION FOR PUP TENT CHARTER](#) Type the form with the Comrades First and Last name, address, etc who plan to join the Pup Tent and Do Cootie Work. Each prospective Cootie must prepare a [Cootie application](#). Type the application or write legibly.
3. [PUP TENT NAME REQUEST](#): Submit Three potential names of the Pup Tent.
4. **Send the three forms, the Cootie applications and a check for \$25.00 to Supreme HQ.** Files can be scanned and emailed and payment can be made with a credit card. Call HQ (412) 824-2240 if there are any questions. Recruit more Comrades to join the Pup Tent. After the Supreme Quartermaster approves the Pup Tent name, the Grand Commander will be informed of the Pup Tent's name. The Grand Commander will then assign the PT number.
5. The prospective members of the new Pup Tent in coordination with the Grand Commander and his officers should schedule Institution of the Pup Tent. See Article II, Section 203 of the MOC Bylaws.
6. After the institution by the appointed officer, the new Cooties will meet and have their election of officers. After that has been completed the newly

elected officers will be installed (usually on the same day by the same individual that instituted the Pup Tent).

7. After the Pup Tent officers have been installed, all new Cootie applications need to be filled out, money collected, and the Election Report needs to be processed on a transmittal and sent to the Grand Quartermaster. Pup tent members must decide what the pup tent Per Capita Tax (dues) will be.
 - a. Per Capita Tax to Supreme is \$12.00 plus \$1.00 for the extension fee.
 - b. Per Capita Tax to the Grand (changes by Grand) plus \$1.00 for the Grand extension fee.
8. [CHARTER CLOSING FORM](#) This is the form used to create the Charter. Type the names of the Comrades identified on the application for Pup Tent Charter along with other Comrades recruited to join the Pup Tent and do Cootie Work (visit veterans in hospitals). This form can be (but not required) held open not more than 90 days, and at the end, submitted to Supreme HQ's for the creation of a Charter. The names on the form will appear on the Charter of the Pup Tent. The new Pup tent shall be instituted within sixty (60) days of the date the Charter is authorized by Supreme HQ's.

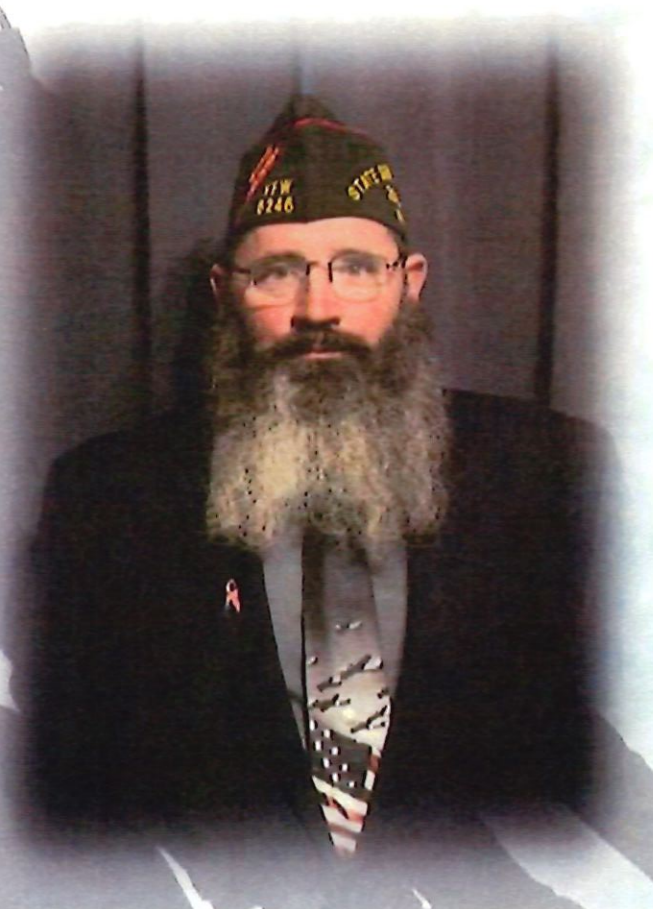

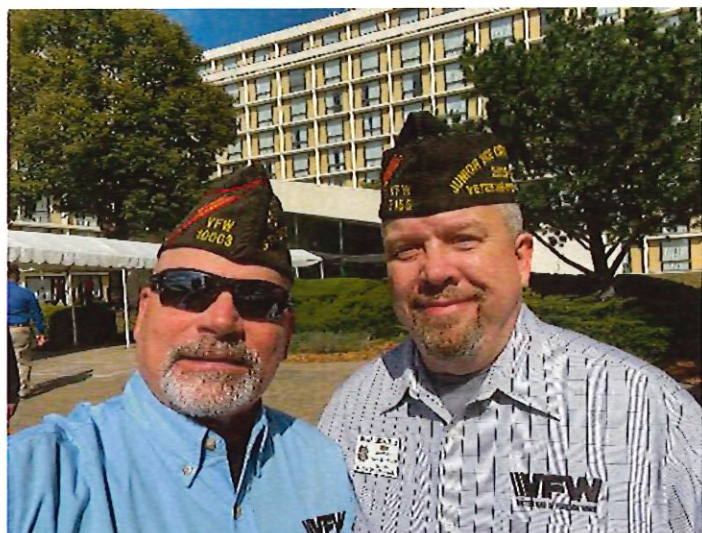

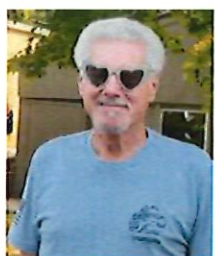

Legislative Priorities 2026 Session

1. In defining an Indiana Veteran's eligibility to receive Veteran's benefits from the State of Indiana remove all references to eminent danger pay, served during war-time, award of a service or campaign medal, hazardous duty, active duty or specific time periods of service.
2. The Hoosier Homeless Veterans Initiative (HVI) requires that homeless shelters in the state reserve at least 1 in 25 beds for single veterans that are experiencing homelessness regardless of separation status. The participating Veteran:
 - a. Maintains regular contact with their county Veterans Service Officer (VSO) or Veterans Affairs (VA) Liaison to ensure they are receiving appropriate benefits.
 - b. Completes a minimum of 10 hours of work a week. If unemployed, the Veteran will volunteer at the shelter in which they are housed.
 - c. Participates in Wraparound Services (Either through the VA or other Public Programs) for Mental Health and Substance Use Counseling, Job Training and Placement, and Educational Support Services.The HVI program will provide a stipend to participating shelters of \$1000 per bed per month not to exceed \$36,000 per year (or 3 beds). The HVI Program participants will have a Maximum of 2 years to transition from a shelter to more permanent housing.
3. Claim Shark legislation: This bill provides that a person may not receive compensation for services related to veterans' benefits matters except as permitted under federal law. It also provides that a person may not receive compensation for referring an individual to another person to provide services related to veterans' benefits matters. It provides that a person seeking to receive compensation for services related to veterans' benefits matters must, before rendering any services, memorialize in a written agreement that is signed by both parties and that complies with federal regulations all terms regarding the payment of fees for services rendered. It provides that a person may not receive excessive or unreasonable fees for services related to veterans' benefits matters. A violation of the provisions of the bill constitutes a violation of the Indiana Consumer Law.
4. Tuition remission: All eligible children of disabled veterans should be entitled to 100% tuition and fee exemption at Indiana higher education schools. Remove served in the armed forces of the United States during a war or performed duty equally hazardous that was recognized by the award of a service or campaign medal of the United States. Change the reside in Indiana at least five (5) years before the person first applies for an exemption to just one (1) year. If Indiana is serious about recruiting Veterans to the state, this is a requirement.


