**TO BE READ AT MEETINGS AND POSTED:**

1. **Attention of Post Commanders** is directed to Section 218 of the Manual of Procedure, "Duty of Trustees." Trustees Report of Audit must be completed in detail at the close of each quarter, one of which ends 31 December 2025. Commanders are reminded that accurate and complete records shall be kept by all persons handling Post funds, including Club Manger, Bingo Chairman and VFW Riders Groups. These records shall be audited by Post Trustees in the same manner as Post Quartermaster and Adjutant records.
2. **Section 220 of the National Bylaws**, "Vacancies and Removal of Elected Officers or Committee Members" states, "Any elected Post officer or committee member removed, by reason of failure to pay current dues or under the provisions of this section shall not be eligible to serve in any Post office or committee in the same administrative year in which the officer or committee member is removed."
3. **Public Law 103-308** designates 7 December as National Pearl Harbor Remembrance Day and requests the flag be flown at half-staff from sunrise to sunset to honor those individuals who lost their lives that day.

**7. Indiana Military Veteran's Legislative Day at the State House** will be 12 January 2026 in the Rotunda of the Indiana State Capitol located at 200 W. Washington St., Indianapolis, IN. The overall event is intended to open communication channels between Indiana Reserve Component, active-duty military veterans and families with their Indiana State Senators and Representatives regarding military and veteran specific legislation moving through the Indiana General Assembly during the 2026 legislative session.



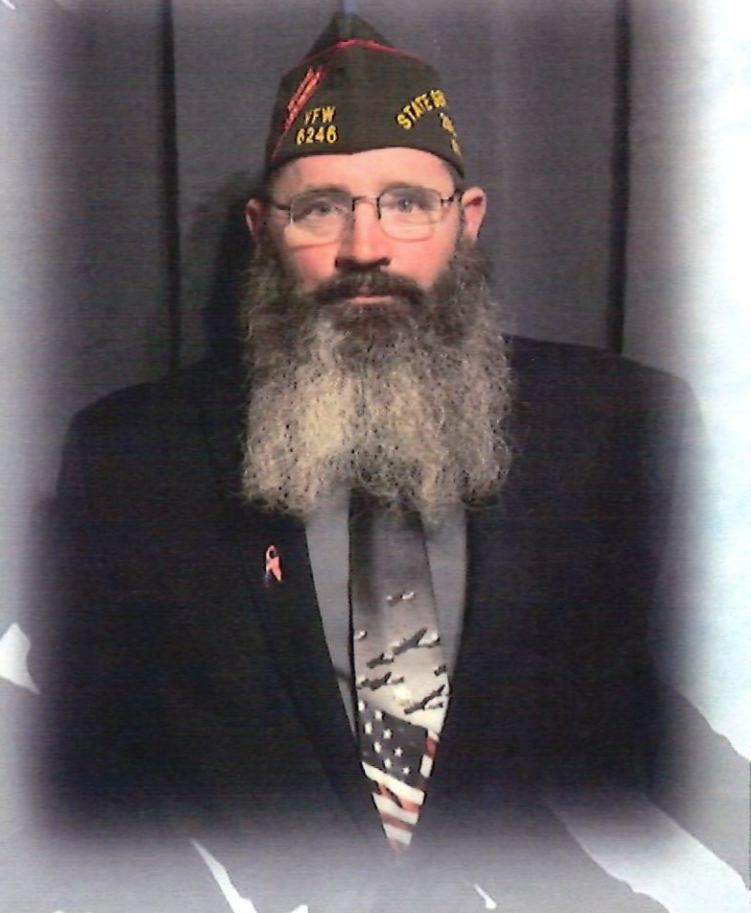
