TO BE READ AT MEETINGS AND POSTED

- 1. **Spring Conference and Banquet** is 21-23 March 2025 at Marriott East. The cutoff for the Banquet Tickets is Friday 14 March 2025. 2025 Spring Conference Agenda is attached.
- 2. **Finance Meeting** is 21 March 2025 at the Marriott East at 4pm. This meeting is open to all who want to attend.
- 3. **District Commander's** a written report must be submitted to the Adjutant after the Council Meeting on Friday night. See attached.
- 4. **VFW National Convention Registration** Section 222 of the Manual of Procedure states each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25.00) which shall entitle the Post to a packet of convention information and materials, and one identified registered delegate for the National Convention. Each additional delegate attending the National Convention will pay a ten-dollar (\$10) delegate fee. Posts are encouraged to register their Post delegate(s) online through the Online Membership System (OMS) or by submitting their National Convention Post and Delegate Registration form that will be mailed to all Posts as part of the Election Report/Convention Registration mailing going out later this month. Registration forms for the 125th National Convention may be mailed to: Convention Registration, 406 W. 34th Street, Kansas City, MO 64111.
- 5. **Post Elections** Attention is directed to Section 217 of the National Bylaws and the Manual of Procedure covering the nomination, election and installation of Post Officers. Post Election Report forms are being mailed to Post Quartermasters with instructions that they complete the form online through OMS or they can complete the form and return directly to National Headquarters <u>immediately following</u> the election of Post Officers but not later than June 1.
- 6. **Post Delegates** Section 222 of the National Bylaws and the Manual of Procedure provides that delegates and alternates for the District Convention and meetings; Department and National Conventions shall be elected at a regular meeting April. Post are entitled to one (1) delegate an done (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post at of 31 March 2025.

7. **District Elections** – Pursuant to Section 403 of the National Bylaws and Manual of Procedure, each District shall hold an annual District Convention for the purpose of electing District officers, such convention to be held not less than ten (10) days nor more than seventy-five (75) days prior to the convening of the Department Convention

Pursuant to Section 403 of the National Bylaws – Regular Meetings, Districts shall hold at least two (2) regular meetings each year for purposes of transacting business and conducting schools of instruction.

Pursuant to Section 417 of the National Manual of Procedure, District officers shall not assume the duties of their office until the Department Commander is installed.

District officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed in accordance with Section 416 of the Manual of Procedure.

- 8. **Attention of Post Commanders** is directed to Section 218 (a) (11) of the National Manual of Procedure, Officers: Duties and Obligations. The Trustee Report of Audit must be prepared in detail within thirty (30) days from the end of each quarter, one of which ends 31 March.


