GET YOUR VETERAN ID CARD



On September 20, 2020, from 1000 to 1400, **VA Northern Indiana Health Care System** will be assisting eligible individuals with obtaining Veteran ID cards and blood pressure checks at:

A Veteran ID Card is a form of photo ID you can use to get discounts offered to Veterans at many restaurants, hotels, stores, and other businesses. Please note: This is not a Veterans Health ID Card.

Am I eligible for a Veteran ID Card?

You may be eligible if you meet both criteria listed below.

Both must be true. You:

- Served on active duty, in the Reserves, or in the National Guard (including the Coast Guard), and
- Received an honorable or general discharge (under honorable conditions)

To prove your character of discharge, you will need to provide a copy of your discharge papers, along with a government-issued photo ID (e.g. Driver's License) when you apply for a Veteran ID Card.

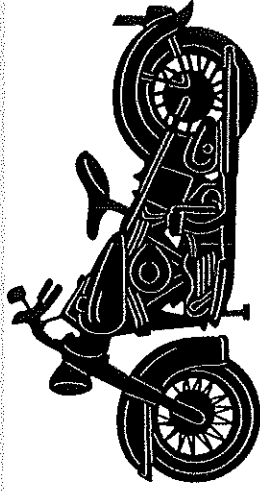

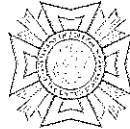
