Duane Sarmiento of Gibbstown, New Jersey, was elected today as the new national commander of the Veterans of Foreign Wars (VFW), a congressionally chartered veterans service organization comprised of approximately 1 million eligible combat veterans and military service members from all six branches of the armed forces.

"Today, I humbly stand here as a testament to the limitless potential of our great nation and a product of the American dream," said Sarmiento during his acceptance speech. "As a kid from New Jersey, I never imagined I would be standing here to accept such a prestigious position in one of the most prestigious institutions in our country."

Sarmiento's election as the VFW's 115th commander-in-chief occurred at the conclusion of the organization's 124th National Convention in Phoenix, Arizona. The gathering was the first national convention held there since 2009. More than 10,000 members of the VFW and its Auxiliary converged on the city to conduct the business of the organization, recognize individuals and organizations for excellence and to elect new leadership for the 2023 – 2024 year.

Sarmiento, who is of mixed Filipino and Italian heritage, is the first person of color elected to lead the 124-year-old organization. He delivered remarks to those attending in person at the Phoenix Convention Center and watching via livestreaming video.

Sarmiento joined the VFW in 1990 at Post 5579 in Gibbstown, New Jersey, where he maintains his Gold Legacy Life membership. He has served in elected and appointed positions at the Post, District and Department levels, culminating with his election as the VFW Department of New Jersey Commander from 2018 to 2019. On the national level, he served as the VFW Inspector General from 2019 to 2020, and served on the National Security and Foreign Affairs Committee, General Resolutions Committee, and as Special Aide-de-Camp. He is a life member of the Military Order of the Cootie, at Ky-Yi Pup Tent #1 in Delaware.

In addition to Sarmiento, other national officers elected were Al Lippardt, a Vietnam War veteran from the Department of Georgia, as Senior Vice Commander-in-Chief, and Carol Whitmore, an Iraq War veteran from the Department of Iowa, as Junior Vice Commander-in-Chief.



# Voice of Democracy Rules and Eligibility

# WHO CAN ENTER

The Voice of Democracy is open to students in grades 9-12 by the Oct. 31 deadline who are enrolled in a public private or parochial high school or home study program in the United States, its territories and possessions; or dependents of U.S. military or civilian personnel in overseas schools. Although U.S. citizenship is not required, students must be lawful U.S. permanent residents or have applied for permanent residence (the application for which has not been denied) and intends to become a U.S. citizen at the earliest opportunity allowed by law. Foreign exchange students, students age 20 or over, previous Voice of Democracy first place state winners, GED or Adult Education Students are ineligible.

## HOW TO ENTER

Record your original 3-5 minute (+ or - 5 second max.) audio essay on a flash drive, or other electronic device. You will submit the recording, typed essay and this completed entry form. Provide these items to your school/group competition or VFW Post for judging.

You must be the sole author of your essay. The recording must be in your own voice and in English. No music, singing, poetry or sound effects are allowed. The body of the essay must not identify you in any way, (including, but not limited to your name, school, city, state, race, or national origin) although the recording & typed essay should be labeled with your name, to show ownership. Your Voice of Democracy entry must be submitted to a participating VFW Post by the Oct. 31 deadline.

# **JUDGING CRITERIA**

Originality is worth 30 points: Treatment of the theme should show imagination and human interest.

Content is worth 35 points: Clearly express your ideas in an organized manner. Fully develop your theme and use transitions to move smoothly from one idea to the other.

**Delivery is worth 35 points:** Speak in a clear and credible manner.

# What is the Voice of Democracy Program?

Since 1947, the Voice of Democracy has been the Veterans of Foreign Wars' (VFW's) premier scholarship program. Each year, nearly 27,000 high school students compete for more than \$2 million in scholarships and incentives. Students compete by writing and recording an audio essay on an annual patriotic theme. This year's theme is, "What are the greatest attributes of our Democracy?"

# Why Should I Enter?

Prizes and scholarships can be awarded at the Post, District, state and national level. Department (State) winners receive an all-expense-paid trip to Washington DC, to tour the city, be honored by the VFW and its Auxiliary and receive their portion of \$171,000 in national awards, the top scholarship being \$35,000.

# The Rules

### Who can enter?

The Voice of Democracy is open to students in grades 9-12 by the Oct. 31 deadline who are enrolled in a public, private or parochial high school or home study program in the United States, its territories and possessions; or dependents of U.S. military or civilian personnel in overseas schools. Although U.S. citizenship is not required, students must be lawful U.S. permanent residents or have applied for permanent residence (the application for which has not been denied) and intends to become a U.S. citizen at the earliest opportunity allowed by law. Foreign exchange students, students age 20 or over, previous Voice of Democracy first place state winners, GED or Adult Education Students are ineligible.

# What do I need to enter?

Record your original 3-5 minute (+ or – 5 second max.) audio essay on a flash drive, or other electronic device. You will submit the recording, typed essay and this completed entry form. Provide these items to your school/group competition or VFW Post for judging. In addition you can submit your emailed entry form, essay, and audio file to the VFW Post upon approval. You must be the sole author of your essay. The recording must be in your own voice and in English. Hearing/speech impaired students should email the Voice of Democracy National Office at youthscholarships@vfw.org for special instructions. No music, singing, poetry or sound effects are allowed. The body of the essay must not identify you in any way, (including, but not limited to your name, school, city, state, race, or national origin) although the recording & typed essay should be labeled with your name, to show ownership.

# Where Do I Submit My Entry?

All entries begin at the VFW Post level. The only exception is where schools/classes/youth groups have large numbers of students and wish to conduct their own competition, submitting one winner for each 15 students to the VFW Post. Individual students may submit their entry directly to the Post. Entries sent to VFW National will be returned. One winner for every 15 entries from each Post advances to District and one District winner advances to the state (Department) competition. If you need help finding a participating VFW Post, follow these instructions: First, visit this website **vfw.org/FindaPost** to "Find A VFW Post." If you do not have success in finding a Post, or if you have trouble getting in touch with them, you can contact your VFW Department (state) office to see if they can offer any information or assistance. # What Is the Deadline for My Entry?

All entries competing at the Post level must be in the hands of that VFW Post by midnight, **Oct. 31, 2023**. It is the responsibility of the student to meet this deadline by submitting their entry to the proper location by ensuring it is a participating Post.

### Originality is worth 30 points:

Treatment of the theme should show imagination and human interest.

### Content is worth 35 points:

Clearly express your ideas in an organized manner. Fully develop

# Patriot's Pen Rules and Eligibility

# WHO CAN ENTER

Patriot's Pen is open to 6th, 7th and 8th-grade students enrolled by the Oct. 31 deadline in public, private or parochial schools in the U.S., its territories or its possessions. Home-schooled students also are eligible. Although U.S. citizenship is not required, students must be lawful U.S. permanent residents or have applied for permanent residence (the application which has not been denied) and intends to become a U.S. citizen at the earliest opportunity allowed by law. (Foreign exchange students or former winners that placed in the National contest are ineligible.)

# **HOW TO ENTER**

Download and complete the Patriot's Pen entry form.

All essays should be typed in English with no color or graphics and 300 - 400 words in length (+ or - 5 word max). The essay must be contestant's original work and a product of the contestant's own thinking. The approach to the Patriot's Pen theme should be positive and clearly focused. Poetry is not acceptable. The body of the essay must not identify you in any way, (including, but not limited to your name, school, city, state, race, or national origin) Quotations may be used sparingly if plainly identified wherever used. A contestant's teacher, counselor or parent may check the essay for punctuation, grammar and/or spelling, but the content must remain the contestant's.

Students can ask a teacher or youth group leader to supervise their progress in the competition. Your Patriot's Pen entry must be submitted to a participating VFW Post by the Oct. 31 deadline.

# J UDGING CRITERIA

Knowledge of the theme is worth 30 points: You must show a thorough knowledge of the theme in your work. Demonstrate you have researched the issue extensively.

Theme development is worth 35 points: Answer all relevant facts about the theme such as the who, what, where, when and why. Relate the theme to your own experiences.

Clarity of ideas is worth 35 points: Write your essay in an easy-to-understand format. Leave your reader with a clear understanding of your explanation of the theme.

# What is the Patriot's Pen Program?

Conducted nationwide, this VFW-sponsored youth essay competition gives students an opportunity to write essays expressing their views on an annual patriotic theme. We invite you to join the more than 73,000 students who participated last year in this contest.

# Why Should I Enter?

Prizes and scholarships can be awarded at the Post, District, State and national level. Department (State) winners receive a portion of \$55,000 in national awards. National Winners will receive at least \$500. The first-place national award is currently \$5,000.

The Internal Revenue Service requires a recipient awarded more than \$599 be given Form 1099 identifying the proceeds as taxable income. This may require the winner to provide their social security number.

# **How Does the Contest Work?**

All entries begin at the VFW Post level. The only exception is where schools/classes/youth groups have large numbers of students and wish to conduct their own competition, submitting one winner for each 15 students to the VFW Post. Individual students may submit their entry directly to the Post.

The contest consists of four levels. The first level (entry) is sponsored by VFW Posts. Post winners advance, one for every 15 **Deadline Information.** entries, to the VFW District (regional) level where the one first-place winner is advanced to the VFW Department (state) level. The first-place winner at the Department level is then advanced into the VFW national competition.

### Who Can Enter?

Patriot's Pen is open to 6th, 7th and 8th-grade students enrolled by the Oct. 31 deadline in public, private or parochial schools in the U.S., its territories or its possessions; or dependents of U.S. military or civilian personnel in overseas schools. Home-schooled students also are eligible. Although U.S. citizenship is not required, students must be lawful U.S. permanent residents or have applied for permanent residence (the application which has not been denied) and intends to become a U.S. citizen at the earliest opportunity allowed by law. (Foreign exchange students or former winners that placed in the National contest are ineligible.)

### How Do I Get Started?

- · Ask a teacher or youth group/club adult leader to supervise the Patriot's Pen writing contest.
- Contact a participating VFW Post and indicate your interest in

- Establish a contact person who is a member of that VFW Post or its VFW Auxiliary.
- · Make sure that your essay is submitted to the VFW Post before the contest deadline of October 31, 2023. You can submit your essay and entry form by email upon the Post's approval. Entries sent to the VFW National Headquarters directly will be returned.

# How Am I Judged?

### Knowledge of the theme is worth 30 points:

You must show a thorough knowledge of the theme in your work. Demonstrate you have researched the issue extensively.

## Theme development is worth 35 points:

Answer all relevant facts about the theme such as the who, what, where, when and why. Relate the theme to your own experiences.

### Clarity of ideas is worth 35 points:

Write your essay in an easy-to-understand format. Leave your reader with a clear understanding of your explanation of the theme.

## What Is the Theme?

VFW's Commander-in-Chief annually chooses the year's theme. The 2023-2024 theme is:

"How are you inspired by America?"

To qualify, all entries must be submitted to a sponsoring VFW Post by midnight October 31, 2023.







# Veterans Memorial Swinging Bridge

The 100-year-old Veterans Memorial Swinging Bridge was rededicated on July 32, 2023, in the Town Park of Winamac, IN. One of the oldest suspension bridges in Indiana, it was erected and dedicated shortly after the Great War. Still feeling the pain of loss, community leaders named the bridge Memorial in honor of "soldiers and sailors" from Pulaski County from all wars.

The celebration mirrored the one held on July 4, 2023, when the bridge was first opened to the public. The biggest difference was that in 2023, at the end of the ceremony, a switch was thrown to illuminate the bridge. This was the culmination of efforts to honor veterans and Gold Star Families by lighting their way home.

The activities on the day of celebration included youth baseball and softball games, live bands, and food vendors. The Culver Summer Schools & Camps, Naval Band was on hand throughout the day to play the National Anthem and other patriotic tunes. Boy Scouts and Girl Scouts were on hand throughout the day to provide whatever assistance was needed, and two Uncle Sams provided toys for children and entertainment for all.


The rededication ceremony recognized veterans and provided formal recognition of POW and Gold Star Families. An Honor Guard crossed the bridge to end the program, and participants were excused to enjoy the amenities of the park until dusk.

At dusk, a grand finale preceded the illumination of the bridge. The closing ceremony featured veterans and volunteers who came forward to honor Pulaski County soldiers from every U.S. war. They wore their own uniforms, or vintage or reproduction uniforms provided by the Pulaski County Historical Society or the Winamac Community High School drama department.

It was for the Pulaski County soldiers who proudly answered the nation's call to duty that this footbridge across the Tippecanoe River was dedicated in July 1923. Now – 100 years later – it was celebrated for that same noble reason.

The illumination project was supported through the years of fundraising activities by Winamac VFW Post 1728, Pfost-Jones. 


